
### **Project Goals**

The proposed School Facilities Project entails the making of substantial repairs and improvements to the Tolland Public School buildings, including:


- Roof replacements for Birch Grove Primary School, Tolland Intermediate School and Tolland Middle School
- Plumbing repairs and upgrades
- Boiler replacements
- Code compliance systems for Public Announcements and Fire Alarm
- Concrete repair
- Floor repair and refinishing
- Replacement of doors
- Carpet replacement
- Paving and Resurfacing
- Ceiling tiles
- Asbestos work

Addressing these items will help in the preservation of school facilities. Preventative and proactive expenditures such as these will likely avert costs due to emergency failures/circumstances.

#### **Project Information**



Up to **38%** (approximately \$3,648,000 of \$9,600,000) of the funding for the projects is estimated to be reimbursable from the State School Construction Grant (**SSCG**).



Approximately 96% of the proposed work is for the Board of Education's oldest schools and 4% of the work is contemplated for the High School which includes repair of flooring and cracks due to building settlement, and warning strip/concrete caulking and repair.

#### **Finances**

- The fiscal impact of the \$9,600,000 cost of the project is offset by the fact that debt obligations for other projects will be declining and then expiring over the next 20 years. As a result, financing the project is expected to have little overall impact on the Town's mill rate.
- Municipal Bond interest rates are relatively low at the present time.
- The Town has been assigned a credit rating of AAA, its highest rating, on its outstanding bond debt by Standard & Poors Global Ratings which has a positive impact on the Town's ability to obtain low interest rates on any bonds issued to finance the project.

A preventative maintenance plan has been adopted to protect the value of the proposed project investments including:

- Semi-annual roof and drain inspections.
- Crack filling of all asphalt and concrete surfaces.
- Preventative maintenance and work order software utilization.
- Certified and timely inspections.
- Increase in service reviews of mechanical, plumbing, and electrical systems.
