# What is plagiarism?

# How do you avoid it?

The dictionary definition of plagiarism is

"an act or instance of using or closely imitating the language and thoughts of another author without authorization and the representation of that author's work as one's own, as by not crediting the original author".



Publication.

## **Periodical Articles**

#### Format:

Author(s). "Title of Article." Title of

Periodical Day Month Year:

pages. Medium of publication.

### **Example:**

Poniewozik, James. "TV Makes a

Too-Close Call." Time 20 Nov.

2000: 70-71. Print.

## Citing Works in Text

- Give only enough information to identify the source (Ex: the author's last name and/or a page number.
- Place a parenthetical reference as close as possible to the source.
- Information in the parenthesis should not repeat information given in the text. (Ex: if you mention the author's name in the sentence, it is not needed in the parenthetical statement).
- The citation should precede the punctuation mark that concludes the sentence or phrase.

## World Wide Web

#### **Format:**

Editor, author, or compiler name (if available). Name of Site. Version number. Name of institution/ organization affiliated with the site (sponsor or publisher), date of resource creation (if available).

Medium of publication. Date of access.

### **Example:**

Felluga, Dino. *Guide to Literary and*Critical Theory. Purdue U, 28

Nov. 2003. Web. 10 May 2006.

# REMEMBER!

- Make the first line even with the left margin
- The second line is indented
- Double space within and between each citation
- Put all citations in alphabetical order
- Italicize document titles
- Medium of Publication is Print or Web
